In 2017, CTKD distributed 9,594 wardrobes and 24,125 pounds of extra items, with 91 percent of shoppers selecting a complete wardrobe (all 21 non-optional pieces). CTKD increased wardrobe distribution by 20% between 2016 and 2017 and has distributed a total of 43,913 wardrobes since opening in 2008.

To be eligible for clothing from CTKD, children must live in the Denver Metro Area or be in foster care, be enrolled in grades preschool-12, or actively pursuing a General Equivalency Degree (GED), and must either be receiving FRL through their school or referred by an authorized person or institution, such as a school employee, religious leader or human service agency. In the 10-county Denver Metro Area, more than 204,000 students qualify for FRL.
